MINUTES OF THE 26th MEETING of the APEX COMMITTEE

The 26th meeting of the State Level Apex Committee on IT&C was held under the chairmanship of Chief Secretary on 29-12-2015 at 10:00 AM in Committee Room No. 1, Secretariat, Jaipur. The list of participants is enclosed at Annexure "A".

The record of discussions held during the meeting and decisions taken are as under:

1. Project: Establishment & Commissioning of Command and Control Center for Surveillance and Incident Response.

The committee was briefed about the Command and Control centre and the Surveillance system to be established in accordance to the directions given by Hon'ble Chief Minister dated 03-Aug-2015. Project entails setting up of Integrated Command & Control Centers for Internal Security, Traffic Management and Emergency Response Services to citizens during emergency. Services pertaining to Administration, Police, Fire and Ambulance would be managed from these centers, for the respective divisions. The project shall contain Video analytics, Digital evidence management, Dial 100 control, ANPR, red light and speed violation detection. Project is being implemented through RISL. RISL had issued NIT and bids have been received.

It was also decided that Home department will transfer funds received from Government of India for setting up National Emergency Response System (NERS) or any similar purpose to RISL, as part funding for the project.

The Apex Committee accorded administrative and financial approval to the project with a project cost of Rs. 22000.00 Lakhs.

2. Project: Integrated e-Panchayat

The Committee was informed that an integrated e-Panchayat application is being developed which will strengthen functioning of Panchayati Raj Institutions (PRI's) and improve management of different schemes being implemented by PRI's.

R.D. & P.R. Department was directed to try and fund the project from devolution under State Finance Commission (S.F.C.).

The Apex Committee accorded administrative and financial approval to the project with a total project cost of Rs.228.12 lakhs.

3. Project: Revenue Court Management System (RCMS)

The Committee was briefed that project is being implemented in compliance of the budget announcement 2015-16 by Hon'ble Chief Minister to automate the functioning of Revenue Courts. Though the platform was used during Revenue Campaign (Nyay Aapke Dwaar), and has facility to let common man directly access digitally signed orders through portal or e-Mitra, the transactions need to be enabled through orders from Revenue Department.

Revenue Department was asked to ensure that system becomes transactions based.

The Apex committee accorded administrative and financial approval of the project with a total project cost of Rs. 119.00 lakhs.

4. Project: Forest Management and Decision Support System(FMDSS)

The committee was briefed about the initiative pertaining to Forest Department wherein a Single Integrated Web Based Management and Monitoring System is being put in place to make their processes and functioning more efficient. One of the priorities of the Platform is to provide citizen interface regarding various services related to Forest department.

The Apex committee accorded administrative and financial approval of the project with a total project cost of Rs. 258.34 lakhs.

5. Project: Financial Inclusion gateway Solution for Co-operative Banks

The Committee was informed that in pursuance to the directions of Hon'ble Chief Minister, establishment of Financial Inclusion Gateway of Co-operative Banks has been undertaken, under Bhamashah scheme to ensure payment through Bio-metric authentication and RuPay cards. The gateway has ensured delivery of financial services at affordable costs to sections of disadvantaged and low-income segments of society, through Co-operative Banks.

The Apex Committee accorded administrative and financial approval to the project with a total project cost of Rs 845.00 lakhs.

6. Project: Design and Development of IT Solution for Bhamashah Swasthya Bima Yojana (BSBY)

The Committee was apprised that in compliance to the budget announcement of Hon'ble Chief Minister, Bhamashah Health Insurance Scheme (BSBY) has been initiated by Department of Medical, Health and Family Welfare. I.T. enabled system for the Scheme has been developed by RISL and base modules have been made live on 13th December 2015. Rs. 959.60 lakhs for the I.T. enablement to RISL are being provided by Medical and Health Department.

The Apex Committee accorded administrative and financial approval to the project cost of Rs. 959.60 lakhs and would be funded by Medical and Health Department.

7. Project: State wide roll out of "Rajasthan Accountability Assurance System (RAAS)"

The Committee was apprised that in compliance to the direction by Hon'ble CM, a pilot was conducted for GPS tracking of vehicles and Biometric attendance for ensuring accountability of the government employees, in Dholpur, and now district wise roll out is proposed. This will also take care of budget announcements pertaining to GPS enablement of vehicles belonging to Police and Transport Department.

Chief Secretary directed that all Collectors and concerned HoDs be issued written directions to effectively use the system for both facilitation and regulation.

The Apex Committee accorded administrative and financial approval to the project with a total project cost of Rs.3955.45 lakhs.

8. Project: Implementation of "Mukhyamantri Jal Swavalamban Abhiyan Management Information System (MJSA-MIS)"

The Committee was informed that the project is being implemented to provide an integrated system for monitoring of water bodies, works management and crowd sourcing, especially in relation to Jal Swavlamban Abhiyan. The System will be also be integrated with "Rajasthan State GIS Application (Rajdhaara)". The project bears the approval of Hon'ble Chief Minister. The funds would be provided by WD&SCD (Panchayati Raj & Rural Development Department).

The Apex Committee accorded administrative & financial approval of the project of Rs.184.25 lakhs.

9. Project: Establishment of Backup power supply at Atal Seva Kendra at Panchayat Level

The Committee was apprised that the Atal Seva Kendras, which have become hub for various e-Governance initiatives for service delivery at Panchayat level, are currently having isolated and unplanned power supplies which need to be strengthened by consolidating and monitoring the existing supplies through SCADA system.

The Apex Committee accorded administrative and financial approval for the project scope and cost of Rs.10158.00 lakhs.

Department of Information Technology & Communication****10. Project: Development of RIICO (ERP) application and establishment of GIS based platform for RIICO**

The Committee was informed that RIICO introduced an Integrated Software Solution (ERP) for automation of its business processes through RISL by leveraging ICT to streamline and improve upon its functioning.

RIICO has further conceptualized to create a GIS based platform for identification, creation, development of various Land Banks and Industrial areas. The GIS application shall be integrated with the IT Enablement application of RIICO to provide seamless experience to both investors and RIICO officials.

The Committee accords administrative and financial approval for the RIICO (ERP) project for total estimated cost Rs. 1048.44 lakhs and b) RIICO (GIS) project for total estimated cost Rs. 282.77 lakhs.

The committee also decided to use common modules of RIICO ERP Application as a product looking into the commonality of 60% similar requirements in other PSUs like RSMM and DISCOM etc.

Chief Secretary further gave following directions for improvement of LITES application of Justice Department:

- i. Justice Department's application "Litigation Information Tracking and Evaluation System (LITES)" should be systemically linked with "Case Information System" of Rajasthan High Court, to ensure timely action along with transactional up-dations and notifications. A joint meeting of Justice Department, Department of IT&C, Registrar High Court and NIC shall be organized in this regard.

The meeting then ended with thanks to the chair.
