 MINUTES OF the 15th MEETING of the APEX COMMITTEE

The meeting was taken by the Chief Secretary on 12.06.12 at 12.00 Noon in the Conference Hall, Secretariat, Jaipur. The list of participants is at Annexure 1.

The agenda note was circulated previously and the record of discussions held during the meeting is as follows:

1. Confirmation of minutes

As no comments were received from any of the members present at the previous meeting, the minutes of the 13th meeting were approved.

2. Action taken report

Secretary, IT&C apprised the committee of the action taken regarding the decisions of the previous meeting.

3. Project for the Computerisation of Department of Labour (DoL), Government of Rajasthan {GoR} – Labour Department Management System (LDMS)

Commissioner, Labour Department, apprised the Committee about the project as per the agenda note wherein it was informed that the 1st Phase (pilot) is to be implemented in the head office and one selected district.

The Committee felt that the 1st Phase of the project be implemented in all the 7 divisional headquarters. The Committee was informed that as per the changes suggested in the 1st Phase, the revised costing for a period of 1 year is as follows:
