With reference to the subject cited above, we have received your forecast estimates of Rs. 1917.80 Lacs for Site Preparation and LAN Cabling works excluding office tables & chairs for District Collectorate, SDM, Tehsil, Horticulture, Labour and Employment Offices across Rajasthan under State-wide Rollout of e-District Mission Mode Project (MMP) against this office letter dated 8th May 2013.

You are requested to kindly execute the work quickly. It is clarified that site preparation work is included in the scope of this project. It may be noted that on work completion, PWD shall provide to RISL –

1. Location-wise expenditure statement bifurcated into two heads –
 - a) LAN Cabling/Networking work; and
 - b) Site Preparation which includes Electrical works and Office Table & Chair (If provided, in the offices where no spare furniture is available to install the computers at proposed I/O point location)
2. Location-wise component-wise (Material, Labour, Supervision/Service Charge, Taxes, etc) expenditure incurred for each head against forecast estimates with completion certificate as per scope of work.

A pilot for this project is being executed in most of the locations of Ajmer and Jodhpur districts. You are requested to undertake the work in these two districts on priority.


1. The expenditure under the project shall be undertaken as per guidelines of DeitY, GoI received by RISL from time to time.
