आदेश

श्री अशोक माहेश्वरी, अतिरिक्त महाप्रबन्धक, (जीएसएम एण्ड डबलूएलएल) BSNL, Rajasthan Telecom Circle, Jaipur को सूचना प्रौद्योगिकी और संचार विभाग, जयपुर (मुख्यालय) में अतिरिक्त निदेशक के रिक्त पद के विरुद्ध प्रतिनियुक्ति पर निम्नलिखित शर्तों के अध्याधीन नियुक्त किया जाता है।

Tenure of Deputation:

The period of deputation of the officer Sh. Ashok Maheshwari, (Staff No.: 20533), Addl. G.M., (GSM & WLL), BSNL, Rajasthan Telecom Circle, Jaipur to the Government of Rajasthan, against the vacant post of Additional Director will be for a period of one year unless extended further subject to maximum of 3 years from the date of assumption of charge by the officer in the State Government till regular personnel is posted on the Additional Director.

Pay and Allowances:

- (i) Sh. Ashok Maheshwari will be allowed to draw pay in his own pay scale as per rules of Govt of India subject to maximum amount admissible to him as he is working in Jaipur (Rajasthan) i.e. same station.
- (ii) As he has been allowed to draw in his own pay scale, therefore, he may be allowed to draw D.A. under the rules of parent organization i.e. Government of India.
- (iii) Project allowance, special allowance, personal pay etc. which are not admissible in the State of Rajasthan, shall not be admissible to the officer/deputationist.
- (iv) Allowances which are not admissible to regular employees of corresponding status in the borrowing organization, shall not be admissible to the officer on deputation/Foreign Service, even if they were admissible in the parent organization.

Transfer T.A.:

T.A. as per state Travelling allowance rules.

Leave:

The officer will be governed by leave rules of his parent organization which would be applicable to him but for the deputation to the state govt.

- (i) Leave Salary and Pension Contribution: during the period of deputation on temporary transfer he will continue to be governed by the leave and pension rules of the parent employer applicable to him before such transfer.
- (ii) Disability Leave: the borrowing organization will be liable to pay leave salary in respect of disability, leave granted on accounts of disability, if any, incurred while on deputation even though such disability manifest itself after the termination of deputation. It shall be restricted to deputation period only.

Provident fund Benefits:

The officer shall continue to subscribe to the provident fund as if he was subscribing prior to processing on deputation. The borrowing organization shall be responsible to forward his contribution on monthly basis to the authorities concerned.

Payment of Group Insurance Scheme:

In case the officer is a member of the Central Govt Employees Group Insurance Scheme 1980, the borrowing organization will effect the recovery of the subscription and credit the same to the relevant head of account. If at any time the recovery of the subscription falls in arrears, the same shall be recovered with interest as admissible under the scheme on accretion to the saving funds in no more than three installments.

Residential Accommodation:

The officer will be entitled to residential accommodation according to the rules of State Government of Rajasthan. If residential accommodation is not provided to the officer he shall be entitled HRA as per rules of the parent department.

Medical facilities:

He will be allowed medical facility as per rules of State Government.

Leave Travel Concession, Transport Allowance and Children Education Allowance:

As Leave Travel Concession, Transport Allowance and Children Education Allowance are not admissible to the employees of the state government and in other cases of deputationist from Government of India, these facilities will not be allowed to him.

Adjustment of Over Payments:

Over payments, if any, made by the borrowing organization will be recovered from the officer even after the expiry of the term of his deputation with state government.

Residual Matters:

While on deputation the officer shall be entitled to all other facilities as admissible to the executives of his status in the state government of Rajasthan. In matters relating to condition of service not covered by these terms and conditions, the officer shall be governed by the rules, regulation and orders as applicable to the government servants of Rajasthan.

Premature Reversion:

Premature reversion to the parent cadre of the deputationist can arise anytime depending upon the need of the borrowing organization of State Government, his services could be so returned after giving a notice of suitable time finalized by the Secretary to the State Government of the borrowing which shall be abided by the deputationist concerned and the parent cadre.
