**Subject : Aadhaar Authentication- Regarding payment/reimbursement of License Fee and Annual Information Security Audit Cost by Sub-AUAs.**

Department of Information Technology & Communication (DoIT&C), Government of Rajasthan is registered as an Authentication User Agency (AUA) under UIDAI, Government of India. Various departments/organizations/PSUs of the Government of Rajasthan are registered as Sub-AUAs under DoIT&C for availing Aadhaar-based authentication services in order to deliver scheme benefits.

UIDAI levies a license fee of Rs. 3.54 Lakh (inclusive of GST) on each Sub-AUA for every two years. Further, as per UIDAI guidelines, Sub-AUAs are required to undergo annual information security audit during on-boarding and every year thereafter, in line with UIDAI's compliance audit checklist and submit the audit report to UIDAI before 31<sup>st</sup> March of every year.

Until now, DoIT&C has been making payments towards the UIDAI license fee on behalf of Sub-AUAs and has also been bearing the annual information security audit cost of Rs. 94,400/- per year per Sub AUA/ KUA. *(cost valid up to 2027, subject to change thereafter).*

With effect from 1<sup>st</sup> April 2025, provision for funds for the above-mentioned tasks will be met in the following manner:

1. Sub-AUAs appointed by UIDAI under DoIT&C shall pay the license fee directly to UIDAI.
2. Sub-AUAs for which DoIT&C has paid the license fee on or after 1<sup>st</sup> April 2025, shall reimburse the license fee to DoIT&C in the bank account as mentioned below.
3. Sub-AUAs shall bear the cost of the annual information security audit. The audit cost of Rs. 94,400/- *(valid up to 2027 and subject to change thereafter)* shall be deposited by the concerned department in the bank account as mentioned below. DoIT&C will issue the work order to its empanelled auditor for conducting the information security audit of Sub-AUAs only upon receipt of the audit cost from the concerned department.
4. Sub-AUAs for which DoIT&C has already issued work order for the information security audit on or after 1st April 2025, shall reimburse the audit cost to DoIT&C in the bank account mentioned below.
