First Mover Advantage Scheme
(in pursuance of Point 2.13.1 of 'IT & ITES Policy 2007')

1. Objective

To provide subsidy to the first five IT/ITES companies with a view to encourage establishment of IT/ITES SMEs in Rajasthan.

2. Nodal Department for sanction and release of subsidy

Department of Information Technology and Communication (DoIT & C) would be nodal agency for operation of the scheme.

3. Eligibility

• **Small and Medium Scale(SME) IT/ITES Industries**

As defined in the notification No.F 5(207)/DoIT/Tech/04 dated 27.11.2007 issued by Department of Information Technology & Communication, Govt. of Rajasthan.

• **Employment**

Directly employing more than 50 employees in IT or 100 employers in ITES sector. Such employment shall be for a period of at least two years for persons domiciled in Rajasthan.

• **Registration**

The companies shall get registered with Director, DoIT & C, GoR after purchase of land for 1st mover advantage. The eligibility of subsidy would however be determined on the basis of date of commencement of operations, which shall also be informed, to the office of the Director, DoIT & C, GoR within 15 days.

4. Amount

Up to Rs.25 Lacs at the rate of Rs. 10,000 per employee to the first five IT/ITES companies investing in the State.

5. Tenure of the Scheme

New IT/ITES Companies/units which are established after the announcement of the new IT/ITES Policy -2007 and up to the period ending on 31st March 2012.

6. Sanctioning authority

A committee under the Chairmanship of Director IT, GOR and consisting of following members

- Nominee of RIICO
- Nominee of STPI

7. Release of Subsidy

After 2 years of operation of the project the company shall have to apply to the Director Department of IT, Government of Rajasthan with proof of

- Operation of the project
- Directly employing more than 50 employees in IT or 100 employees in ITeS sector
- Employment for a period of 2 years for persons domiciled in Rajasthan.
