MINUTES OF the 18th MEETING of the APEX COMMITTEE

The meeting was taken by the Chief Secretary on 08.11.12 at 4:00 PM in the Committee Room - I, Secretariat, Jaipur. The list of participants is at Annexure 1.

The agenda note was circulated previously and the record of discussions held during the meeting is as follows:

1. Confirmation of minutes

As no comments were received from any of the members present at the previous meeting, the minutes of the 17th meeting were approved.

2. Action taken report

Secretary, IT&C apprised the committee of the action taken regarding the decisions of the previous meeting.

3. Review of utilization of Plan funds (object head – 62) for e-Governance by major departments Higher Education Department

The status of expenditure, as per the agenda note, was reviewed by the Committee. All the departments were directed to ensure timely utilization of the allotted funds.

Representative of Water Resources Department informed that not all funds will be used. It was directed that the unusable funds may be finalised and the amount be surrendered by the Department during the R.E budget finalisation for the current financial year (2012-2013).

4. Core banking solution for Rajasthan State Cooperative Bank and all District Central Cooperative banks

Principal Secretary, Cooperative Department briefed the Committee about the project as per the agenda note.

The Committee accorded approval to establishment of self-owned data centre by the Rajasthan State Cooperative Bank while ensuring integration of all the banking applications namely IT enablement of RSCB, DCCBs and PACs. The Committee also observed that as suggested by SeMT, for successful execution of the project, procurement of hardware and software, FMS and maintenance services of the data centre should be done through a single party, with service level agreement.

5. Roll out of web-based Apna Khata

Principal Secretary, Revenue Department informed the Committee of issues / problems being encountered by various district collectors in updation of mutations. SIO-NIC was advised to look into the matter.

In order to resolve the issues in the application software, support from NIC and connectivity, Chairman - Apex Committee directed that a separate meeting may

be scheduled under the chairmanship of Principal Secretary – IT&C with SIO – NIC, Registrar – Board of Revenue, representative of Revenue Department, select district collectors and representative of BSNL.

6. Common Service Centres (CSC)

i. Integration of CSC like kiosks in the CSC network

Secretary, IT&C apprised the Committee about the agenda item as per the agenda note. The Committee was informed that as of date, 990 kiosks other than CSC are operational in the State under the brand name 'e-Mitra'.

The Committee approved the integration of all the e-Mitra kiosks working on the same framework as that of the CSC project and offering various G2C and B2C services to the urban masses with CSCs.

ii. Pending commission charges

Secretary, IT&C informed the Committee about the commission charges pending with DISCOMs and PHED under the CSC / e-Mitra project.

Chairman, Apex Committee advised the concerned departments to expedite the payment. It was also decided that in future, all commission charges will be deducted at source and the remaining amount of collection funds will be deposited by the service providers in the accounts of the concerned departments.

7. IT enablement of RPSC – Phase II

The Committee was informed, as per the agenda note, about the project that is to be outsourced to RISL. The financials for the project are as follows:

- Chairman – Apex Committee advised to explore the use of the vast network of mobiles that exists in the government sector for quick and timely dissemination of information, orders, direction to the government officials / officers.
- He also advised integration of mobile phone closed user groups of different departments with each other for expeditious knowledge sharing and information transfer.
