Terms & Conditions

1. DoIT&C, Govt. of Rajasthan shall extend the "Short Message Service (SMS) Connectivity" offered by C-DAC, Govt. of India undertaking to all the Govt. departments and agencies across the nation.
2. The SMS Services are provided on an "AS IS and AVAILABLE" basis without warranties of any kind, either express or implied, including but not limited to warranties of title, non-infringement or implied warranties of merchantability of fitness for a particular purpose.
3. C-DAC shall provide SMS termination capability on reasonable efforts basis on all available mobile networks in India, both GSM & CDMA.
4. The service would enable the end-user/ department/ agency to send SMS or Transactional message from a web/ application software across India as per the agreed terms and conditions and cannot be extended further to any other end-user/ department/ agency.
5. End-user/ department/ agency shall not send or attempt to send any international SMS.
6. No Promotional and Unsolicited Commercial Communication i.e. any message, voice or SMS, made through telecommunications service, which is transmitted for the purpose of informing about, or soliciting or promoting any commercial transaction in relation to goods, investment or services shall be sent by end-user/ department/ agency.
7. End-user/ department/ agency shall make reasonable efforts not use the C-DAC's SMS connectivity for any other purpose not envisaged under this application form and or for transmitting SMS's which are obscene, abusive, offensive, unlawful, illegal, sensitive in nature, communal, unauthorized, or compromising the National Security etc. or which are in violation of any Applicable Laws, public policy, any statutory directives or orders for the time being in force. The use of the Services for anti-national activities would be construed as an offence punishable under the Indian Penal Code or other applicable law.
8. The end-user/ department/ agency shall use the services in compliance to the applicable laws i.e. Cyber Law, the Indian Telegraph Act, The Wireless Telegraphy Act, TCCCP Regulations and the Telecom Regulatory Authority of India Act from time to time.
9. End-user/ department/ agency shall be solely responsible and liable for any wrong and/or illegal message being transmitted through SMS connectivity or for any use of the Services in violation of TCCCP Regulations and shall take necessary corrective action.
10. DoIT&C/ C-DAC has no control on delivery rate and that it varies based on the response of telecom networks of the operators. Therefore, no assurances are made by the C-DAC in respect of delivery rate.
11. DoIT&C/ C-DAC may, without any notice, refuse, curtail, modify, suspend, disconnect or terminate the Services in whole or in part at any time if so directed by any statutory authority or judicial forum.
12. DoIT&C/ C-DAC shall not be liable to Customer for any loss, costs or damage whatsoever or howsoever caused, arising directly or indirectly in connection with the Services.
13. End-user/ department/ agency shall be required to pay penalty as may be specified by TRAI/ Telcos, on issue of each notice for sending unsolicited commercial communication, an amount, as applicable (First Notice: Rs. 25000/-, Second Notice: Rs. 75,000/-, Third Notice: 80,000/-).
14. In case of issue of Third notice by the Access Provider to the End-user/ department/ agency for sending unsolicited commercial communication, without prejudice to the amount which shall be paid by him, the telecom resources allotted to him shall be disconnected without any further notice. The Access Provider shall intimate the name of the end-user/ department/ agency to the agency maintaining the National Telemarketer Register for entering the name in the black list and it shall not be removed from the black list before the completion of the period of two years from the date of entering his name in such black list.
15. End-user department should timely make the payment i.e. SMS charges (0.03 Paisa per SMS + applicable taxes), upon receiving intimation from DoIT&C/ designated agency. No charges would be levied for the SMS sent uptill 31st December, 2012.
16. The End-user/ department/ agency will pay promptly inter connect utility termination charges (IUC) at the rate of Re. 0.05 (five paisa only) per Promotional Messages, if any, sent by him as levied by TRAI vide its notification No.352-4/2011-CA (QoS) dated October 25, 2011. Such interconnect charges shall be separate and the end-user/ department/ agency shall be liable to pay the inter-connect charges unconditionally in the true letter and spirit of said TRAI notification.
